Based on our records, Rod has presented 5 Minnesota CLE seminars on How to Collect Debts in Minnesota (2002 + 2003), The Debtor-Creditor Conference (2011), What Lawyers Handling Debt Collection Matters Need to Know (2012), and the 2013 Debtor and Creditor Conference.
